

## **Board Elections – 2024**

The week of January 29<sup>th</sup> the CIAB will begin board elections for the seats highlighted in gray below that expire on June 30, 2024. Board election materials will be sent via email. You are welcome to return your nomination and/or ballot via email to info@cherryboard.org.

In Northern Michigan the grower member seat expiring on June 30, 2024, will become a handler seat. This is due to section 930.20 (d) in the Code of Federal Regulations, which states "the ratio of grower to handler representation in districts with three members shall alternate each time the term of a Board member from the representative group having two seats expires". Therefore, the Board representation in Northern Michigan, beginning July 1, 2024, will be one grower member, two handler members and their respective alternates.

In crop year 2023 Central Michigan's three-year average production was greater than 40 million pounds. Therefore, per the Code of Federal Regulations (CFR) §930.20(b) board membership for Central Michigan will increase by one seat. This will change Central Michigan to one grower and two handler seats. The additional seat will flip between a handler and grower after the three-year term expires.

Danielle Brien, the current handler member in Southern Michigan is term limited as she has severed two consecutive 3-year terms on the board as a member.

We look forward to your participation in the election process of CIAB representatives.
